### Scope of our request

We also require confirmation you have not deleted, and will not delete, any personal data held by you after being informed of this Subject Access Request.

- 2. An explanation of the purposes for which the data is processed;
- 3. An identification the source or sources of the data;
- 4. Detail of to whom the data has been disclosed or may be disclosed, in particular recipients in third countries or international organisations;
- 5. Detail of the envisaged period for which the data will be stored, or, if not possible, the criteria used to determine that period; and
- Confirmation as to whether there has been any automated decision-making using the data, including profiling, and if so, any meaningful information about how it was based, as well as the significance and the envisaged consequences for our clients of such processing.
